16:53 Rod Cowan (Westside) gave a report on a proposed top ten state record list. The committee will revise the criteria and adopt the HS Federation's declaration form. A final revision will be presented at the winter clinic.

17:14 John Jones (Spring Valley) discussed membership dues. Bob Jenkins (Northwestern) proposed that membership dues be increased from \$5 to \$8. Rick Crumpler (Spring Valley) seconded the motion. The motion passed unanimously.

17:16 Bob Jenkins (Northwestern) proposed that the association recommend to the High School League Executive Committee that 3A/4A continue with a two-day state track meet schedule. The motion was seconded by Jim Kilbreth. The motion was amended to include that the field events contested on Friday night and Saturday rotate annually between 3A and 4A. The motion passed unanimously.

17:24 Ed Boehmke (Eastside) proposed an amendment to the constitution that allows for the Shrine Bowl Assistant Coach to be selected at the Cross Country Coaches meeting. The motion was seconded by Glover Smiley (Spartanburg). The motion passed unanimously.

17:34 John Jones (Spring Valley) discussed indoor track as a sanctioned sport in the state. It was recommended that President Jones retype the proposed letter given out at the clinic to include several changes:

- strike guideline #2 concerning no dual meet participation
- include in guideline #3 any indoor meet with 10 or more teams participating in the meet and using FAT
- include in guideline #4 that the 1000m, 500m, and 300m qualifying standards may be used to qualify for the 800m, 400m, and 200m respectively
- include in guideline #5 that a school may only enter one relay
- change guideline #6 to scoring through six places instead of eight

The new letter is to be distributed through the association email list to all schools interested in participating in indoor track. Schools interested in indoor track need to then pass the information on to their Athletic Directors and Principals.

18:14 Rick Crumpler (Spring Valley) proposed that the rules meeting be changed to a mandatory session. The motion was seconded by Calvin Hudgins (Northwestern). The motion passed unanimously.
