Subject: Minutes of the Winter Clinic, SCHSL office, Columbia, SC.

- 10:08- President Bob Jenkins(Northwestern High) opened the winter clinic of the South Carolina Track & Cross Country Association.
- 10:10- Pete Ayoub, executive director of the SCHSL, spoke on a run down about the new building the HSL has just moved into this year.
- 10:26- President Jenkins reported on the 400m hurdle committee report. The HSL as well as the National Federation, has approved the 400m hurdles to be included in the track program starting in 1995.
- 10:38- LF Sanders(Allendale-Fairfax High) read the minutes of the 1993 summer clinic and gave a financial report. Our balanced is at \$4500. It was approved by George Johnson(Ben Lippen School) and seconded by Rut Dingle (Sumter High). It passed.
- 10:43- Ron Sullivan(Belton-Honea Path High) gave the Shrine Bowl Run report. He reported that everything went fine. (Actually, it went great, and for the second straight year we beat the North Carolina group to the stadium. What is wrong with the boys from up north?)
- 10:46- Report on the NHSCA. President Jenkins reported that we are no longer a member of the above named association. A new organization has been formed for track= The United States Track Coaches Association. The President ask for people to give their time to help set the grass roots of this new organization for South Carolina. Contact President Jenkins at Nortwestern High of Rock Hill, SC, if interested.
- 10:54- High School/Youth Track Coordination. Mickey Gist of SC/USATF was supposed to be present; but, atlas (Shakespere baby, not a map), he was not present. Coach Ed Boehmke(Eastside High) carried on. It was moved by Mike Moore(Irmo High) that the President(Bob not Bill) approach Mr. Gist in coordinating activities in track. It was seconded by Coach Dingle. It passed.
- 11:05- Review of the 1993 Cross Country Season. Coach Boehmke made a plead to the coaches about keeping their athletes away from certain areas(ie: finish line and scorer's desk). He also mention that the forms for running at Ft. Jackson are not being filled out correctly. The State meet deadline for XC '94 will be moved to 8th October.

- 11:14- Newspaper polls. Report given by Willie Wooden(Riverside High) with no action taken.
- 11:32- SCTCCCA Coach of the Year- Cross Country. Ted Whitaker (Hilton Head High) gave out the awards to:
Delmer Howell, Mauldin High, Girls' 4A; Willie Wooden, Riverside High, Boys' 3A; Chuck Parker, Hanna High, Girls' 3A; and Jim Crawford, Crescent High, Boys' 2A, who was absent. Irving Batten, Summerville is the Boys' 4A winner and his award was presented to him at the Summerville awards banquet.
- 11:36- SCACA Coach of the Year voting. President Jenkins presented the names of 5 coaches for the boys' division, and 5 coaches for the girls' division to the membership. One extra name was added by Coach Boehmke to the boys' list. All 11 names will be presented to the SCACA.
Nominated: Boys': Irving Batten; Steve Cox, Dutch Fork; Jim Crawford, Crescent; Jim Kilbreath, Spartanburg; Richard Zeller, Wade Hampton G; and Willie Wooden.
Girls': Ed Boehmke; Jim Hamby, Lexington; Delmer Howell, Mauldin; Eileen Kilbreth, Spartanburg; and Chuck Parker.
It was moved to approved by Coach Aingle, and seconded by John Jones(Spring Valley High). It pass.
- 11:41- Cross Country Coaches Survey. This was conducted by Coach Howell. He promised to get the results back to the association.
- 11:45- Track proposal. Proposed by the executive committee and seconded by Glover Smiley(Spartanburg High). Add the 4x800m Relay to the track meet. 37-Yes, 8-No. It pass.

Coach Kilbreth proposed the 4x800m relay be the first event. Seconded by Coach Smiley. 48-Yes, 0-No. It pass.

Coach Jones proposed to limit the number of events entered to 3 open and 2 relays, there was only 1 vote in favor. It failed.
- 12:14- Publications and rule changes. Presented by Coach Sanders.
- 12:33- 1994 Track and Field Calendar. Presented by Coach Boehmke.
- 12:44- 1994 Coaches Classic Meet. Presented by Coaches Boehmke and Moore. There will be only 6 sites for the qualifying.
- 12:56- Nominations for Office. President Jenkins took down names of anyone who would interested in running for office. Our present officers are to step down at the end of this year.

12:58- New business.

Coach Jones proposed that if the state meet is rain out; ask the HSL to run the meet on the next available date at the state meet site. Seconded by Coach Dingle. It pass.

Coach Jones proposed that if the State PV is canceled, the event will be conducted the next day at a different site. Seconded by Tim Vaughn(South Florence High). It pass.

Coach Jones proposed the honest effort rule will be enforce starting at the Lower/Upper State fixtures. Seconded by Larry Bost(Lexington High).

16-Yes, 14-No. It pass.

Special note: There is nothing in the current rule book about the "honest effort"; however, please check the new casebook page 11, "Terms and conditions of competition".

Coach Howell proposed that all 3-4 qualifiers at the Region meet must declare before 30 minutes of the end of the meet so others may be moved up.

18-Yes, 5-No. It pass.

Special note again: Please look on page 34 of the current casebook- "Qualifier withdraws- No replacement."

Carlisle Koonts(North Augusta High) seconded the above proposal.

Coach Boehmke proposed that the HSL moved the start of the track back one week. That means the State fixture would be held on the 3rd week of May. Coach Moore seconded. It pass.

Coach Jones proposed that when any athlete is left in the HJ and PV, he/she will have 6 minutes to complete their trial. Seconded by Chris Thibaudeau(Lower Richland High). 12-Yes, 6-No. It pass.

13:46- President Jenkins adjourn the winter clinic. Next meeting= Coaches Association summer clinic in July.
